Privacy Policy

- a. Commitment to Privacy Protection. ADESA, Inc. ("ADESA") and OPENLANE, Inc. - xv. Company may provide its banned dealer list (which includes the name and address of the affected business, names of all individual representatives of the affected business whose privileges have been suspended, and the reasons for the suspension) to third parties including third party auctions.
- xvi. Company may share personal and/or aggregated information that you have provided with other business divisions within the KAR Auction Services, Inc. ("KAR") group of companies. Company shares credit information concerning dealer with its sister companies.
- e. **Limiting Use, Disclosure and Retention.** Personal information shall not be used or disclosed for purposes other than those for which it was collected, except with your consent or as required by law. Personal information shall be retained only as long as necessary for the fulfillment of those purposes or as required by law.
- f. Consent. Whenever possible, Company will seek your consent to use and disclose your personal information at the same time it collects such personal information. By providing personal information to Company, by conducting business at Company or by using Company services you are consenting to the collection, use and disclosure of personal information for the purposes set out in this Privacy Policy.
